When can you apply on behalf of someone else?

You can complete and sign an enrolment form on behalf of someone else in any of the following three situations:

- the applicant is unable to sign because of a mental impairment
- the applicant is unable to sign because of a physical impairment
- the applicant is overseas.

Who can apply on behalf of someone else?

You can apply on behalf of someone else in these situations if one of the following applies:

Situation	You can sign if one of the following applies
The person has a mental impairment	<div>You are enrolled to vote</div> <div>You hold enduring power of attorney for the person</div> <div>You are the person's welfare guardian appointed under section 12(1) of the Protection of Personal and Property Rights Act 1988</div>
The person has a physical impairment	<div>You are enrolled to vote</div> <div>You hold power of attorney for the person</div>
The person is overseas	<div>You are enrolled to vote</div> <div>You hold power of attorney for the person</div>

Is it compulsory to enrol to vote?

A person must enrol if they live in New Zealand and are:

- 18 or older, and
- a citizen or a permanent resident of New Zealand, and
- have ever lived in New Zealand continuously for one year or more.

A person can enrol at 17 but can't vote until they're 18.

Eligible people with mental or physical impairments should be enrolled to vote.

Voting is not compulsory.

If you live overseas, you can enrol if you're a:

- NZ citizen who has been in NZ within the last 3 years, or
- NZ permanent resident and have been in NZ in the last 12 months.

It is not compulsory to enrol if you live overseas.

Personal safety

If having information on the published electoral roll threatens a person or their family's personal safety, they can apply to go on the unpublished roll. The unpublished roll is confidential. To learn more visit us at vote.nz/form.
